<p>203</p> <p>On the date and time above I Officer Gramling was dispatched 217 Horseshoe Bend, Madison Al 35758. Upon arrival I made contact with Mrs. Chafin and handcuffed her behind her back with handcuffs double locked for officer safety. I then explained to her that we received a call that she was trying to stab her husband. Officer McAbee questioned Mr. Chafin. Mr. Chafin stated that he and his wife were going through a divorce and they have one child in common. Mr. Chafin also stated that he and his wife have had marital problems in the past. While Mr. Chafin was asleep in bed he awoke with his wife standing over him with a kitchen knife. She stated "You are not getting out of here alive" Mr. Chafin flung his beds sheets at her, so he could escape. Mr. Chafin ran into his child's room and locked the door and called this agency. I tried to speak with Mrs. Chafin to get her side of the story, but she was belligerent and to intoxicated to speak with me. After speaking with Mr. Chafin again we decided to arrest Mrs. Chafin for the above charge. Mr. Chafin was given a domestic violence packet. Upon transporting Mrs. Chafin to PSB she started kicking the windows of the patrol car. Officer McAbee and I stopped the patrol car and applied the leg shackles and double locked them. Officer McAbee and I brought Mrs. Chafin into PSB for processing. After processing Mrs. Chafin at PSB a decision was made to apply hobbles to Mrs. Chafin. Officer Niles applied the hobbles to Mrs. Chafin and we began transporting her to Decatur City Jail. While enroute she yet again became combative. While stopped on 565 at County Line Rd. Officer Grigsby assisted Officer McAbee and I restraining Mrs. Chafin. After being resecured she was then transported to Decatur City Jail and processed. She was given a court date 2/25/2011 and a bond of \$1000.</p>
